This memorandum of understanding (here in after called as the 'MOU') is entered into on this the (Date 01-09-2017) by and between Govt. College Timarni, Dist- Harda (M.P.) (Here in after first party) and Nice Computer Education Timarni Dist- Harda (M.P.) (Here in after is called second party).

The Parties,

Govt. College Timarni, Dist- Harda (M.P.) is established in 1983, this institute is affiliated with Barkatullah University Bhopal and the course which are running here are of Science, Arts & Commerce stream. It is accredited twice by NAAC with B+ and B grade.

And

Nice Computer Education Timarni Dist-Harda (M.P.)

ARTICLE 1: OBJECT

Both institutes agree to develop the following collaborative activities in the academic areas of mutual interest on the basis of equality and reciprocity. This MOU is being signed by purely with the intention of academic and scientific co-operation without any financial liabilities.

The two institutions shall seek to promote

g. Faculty exchanges

A specific plan will be worked out for each activity; setting forth detailed arrangements for collaboration will be agreed. Terms and conditions for each visit or such exchange including those concerning monetary implications will be worked out between the Institutes. A Separate agreement will be entered as per requirements.



h. Student Exchange

Govt. College Timarni, Dist- Harda (M.P.) and Nice Computer Education Timarni Dist- Harda (M.P.) agree that student exchange will be guided by principles listed below:

- XI. To propose and engage jointly in research or training program sponsored by funding agencies and to invite each other's faculty to participate therein.
- XII. The provision of culture and intellectual enrichment opportunities for staff and students of both institutes.

ARTICLE 2: COORDINATION

Each institution shall appoint one member of its teaching/ research faculty to coordinate the program on its behalf. Further, a coordination committee consisting of a program coordinator from the side of Nice Computer Education Timarni Dist-Harda (M.P.) and a program coordinator from the side of Govt. College Timarni, Dist- Harda (M.P.) will periodically review and identify ways to strengthen cooperation between the two institutions.

ARTICLE 5: AMENDMENTS/ MODIFICATIONS

This MOU may be amended or modifies by a written agreement signed by the representatives of both institutions.

ARTICLE 6: ADHERENCE TO LAWS

Participating faculties, Staff and students involved in any activities under this memorandum must adhere to the law of the country and rules and regulations of the institutions.

ARTICLE 7: LEGAL EFFECT

Nothing in this memorandum shall be constructed as creating any legal relationship between the institutes. This Memorandum is a statement of intent to foster genuine and mutually beneficial collaboration

ARTICLE 8: DISPUTE RESOLUTION

In case, there be a dispute to any aspect of academic cooperation. Authorized Signatory, Govt. College Timarni, Dist- Harda (M.P.) and Authorized Signatory Nice Computer Education Timarni Dist-Harda (M.P.) will jointly resolve the dispute in a spirit of independence Mutual respect and shared responsibility.

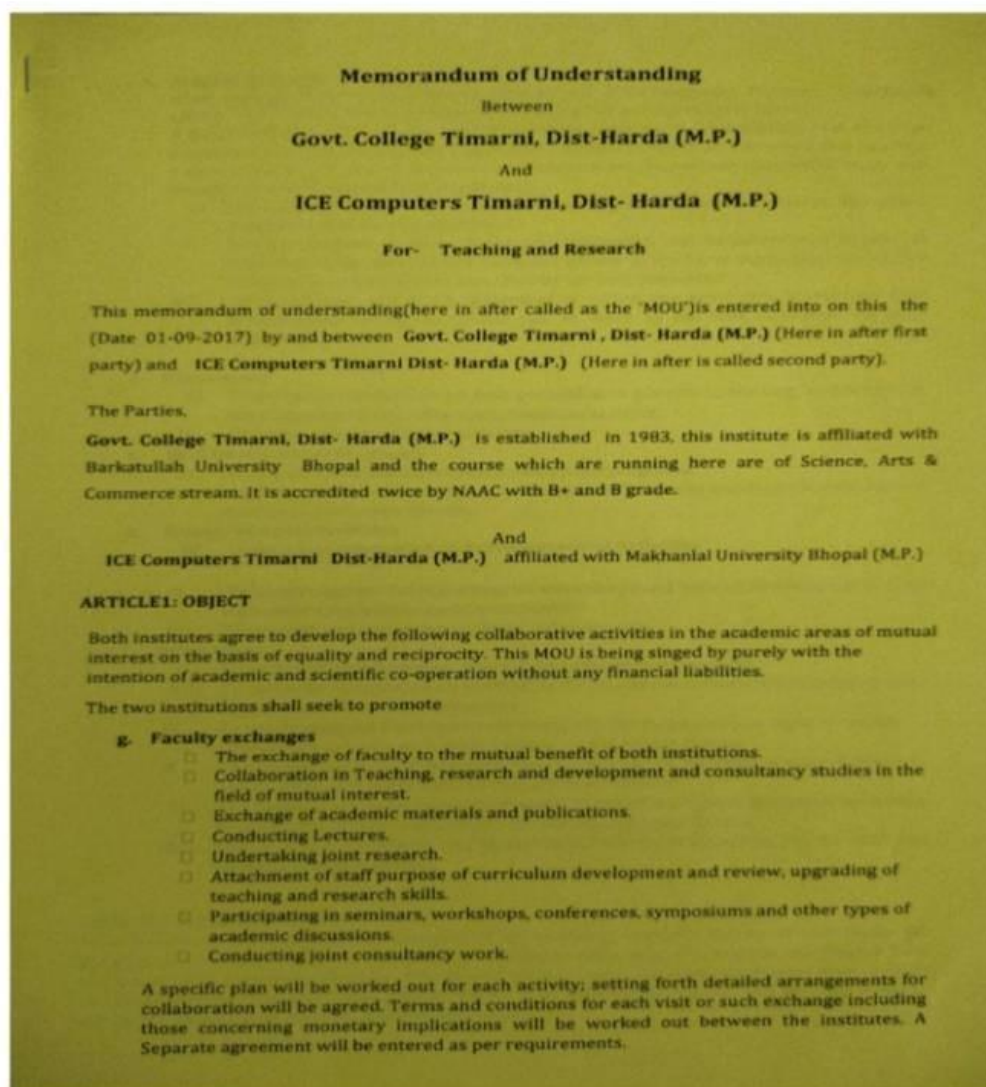

NOW THEREFORE the parties agree as follows:


SECTION - I
